Funding Opportunity

United Way of Central and Northeastern Connecticut (United Way) is making funds available for eligible organizations to apply for one-time funding to support residents who have been adversely impacted by the pandemic.

Eligibility Requirements

Organizations must meet the following requirements in order to apply:

- Be exempt from federal income tax under the Internal Revenue Code, Section 501(c)(3) or have a fiscal sponsor/agent that is exempt; public entities (i.e. school district, municipality, etc.) will also be considered.
- Organization/fiscal sponsor has been in operation and has had tax exemption for a minimum of three fiscal years.
- Organization/fiscal sponsor has an independent annual audit or financial review which reflects a clean opinion and a sound financial position.
- Must be a registered nonprofit with the State of Connecticut Department of Consumer Protection Charity Unit and abide by all state laws regulating charities (if applicable).
- Serves individuals/families in United Way's catchment area.
- Affirms United Way's Policy of Non-Discrimination.
- Grants permission by virtue of the application that information can be shared with other philanthropic partners as we work to coordinate efforts and maximize resources.
- Will actively assist marketing efforts in providing human interest stories and related information, promoting United Way Neighbors in Need and recognizing United Way as a partner.

Community Priorities

Asset-Limited, Income-Constrained, Employed (ALICE) households are those that have at least one adult working yet walk a tight financial tight rope, unable to make ends meet. In the current crisis, we know that many more households are facing this challenge, and that communities of color have been disproportionately impacted. To address increased needs in our community, we will support continued response and recovery efforts to address the following with an emphasis on serving those who have been disproportionately impacted:

- Ensuring quality early childhood education services are operational so that parents can go back to work, and children can stay on track to achieve developmental milestones;
- Opportunities to engage youth in staying on track with academic achievement through interventions including educational distance learning, positive youth development, and work-based learning activities;
- Individuals in need of assistance with transitioning to employment, accessing income supports, and/or other services that relate to economic mobility;
- Individuals in need of services as a result of job loss, reduction in wages or other issues caused by the pandemic such as: food, shelter, safety from domestic violence/sexual assault, mental/physical health, rent/mortgage or utility assistance, or other identified needs.

Proposal Submission and Review Process

- Applications are available on our website and will be accepted on a rolling basis. Access to our proposal and required documents for submission can be found <u>here</u>.
- Organizations that have not previously applied for funding through United Way of Central and Northeastern CT will be required to create an account in order to access the application.
- Organizations that have submitted applications for FY '20-21 United Way *Community Investment* funds should contact their staff liaison before submitting a *Neighbors in Need* application.

• Proposals will be reviewed and evaluated by United Way staff and volunteers on a monthly basis. Funding amounts will be determined based on funds available at the time of review, number of proposals, and ability to demonstrate that funds will directly support aforementioned priorities.

Notification

Notification of awards will be made the month following submission. Agencies that are approved for funding will receive an award letter explaining reporting requirements, partnership expectations, and details regarding payment of award.

<u>FAQ</u>

I'm an individual who's been affected by COVID-19. Can the *Neighbors in Need* Fund help me? We understand many individuals and families have been affected by the outbreak already and more will continue to be affected. United Way is working to move resources to community-based organizations that are directly supporting residents and families who are most affected by emerging health, economic, and social impacts.

While we are not able to provide grants to individuals, we will be funding community-based organizations that have experience and history of providing people and families with services and support. I want to donate. Can I restrict my funding to a prioritized grantee?

The *Neighbors in Need* Fund was created in the hopes of providing a way to coordinate as many resources as possible in response to the greatest community needs. Funds contributed to *Neighbors in Need* may not be designated to a specific agency at this time.

Should I give to the Neighbors in Need Fund instead of making other donations?

Neighbors in Need was not created to be the only vehicle resourcing critical community activities during this outbreak. Rather it is working to facilitate getting more targeted resources into the community where they are needed most. If the *Neighbors in Need* priorities align with your values, please consider donating. However, this is a critical time for so many, including the nonprofit organizations who've benefited from your giving in the past, as well as those who've had to cancel their annual fundraising events or depend heavily on public gatherings. Please continue to give to organizations you regularly support, and those that need your help at this crucial time. Now is the time to double down for our community as we gain greater awareness of the depth and scale of the long-term ramifications of the outbreak.
