As members of our Tocqueville and Constitution Societies, your generous contributions to the 2021 United Way Community Campaign helped us build equitable outcomes for children and families in our community. During the 2021 United Way Campaign, **more than 650 Tocqueville Society and Constitution Society members donated \$1,000 or more.**

Your philanthropic leadership investment, combined with other gifts, helped raise nearly \$8 million and made a measurable difference for children and families. Here's how:

- 93 percent of students improved literacy skills through participation in weekly one-on-one reading sessions with a United Way volunteer.
- 7,300 people found safety and protective services from sexual assault or domestic violence.
- 75 percent of students kindergarten through eighth grade improved their academic performance against grade-level standards.
- 10,122 people filed their 2021 tax returns at no cost through Volunteer Income Tax Assistance sites and MyFreeTaxes.com returning **\$27.5M** in federal refunds and credits to our community.

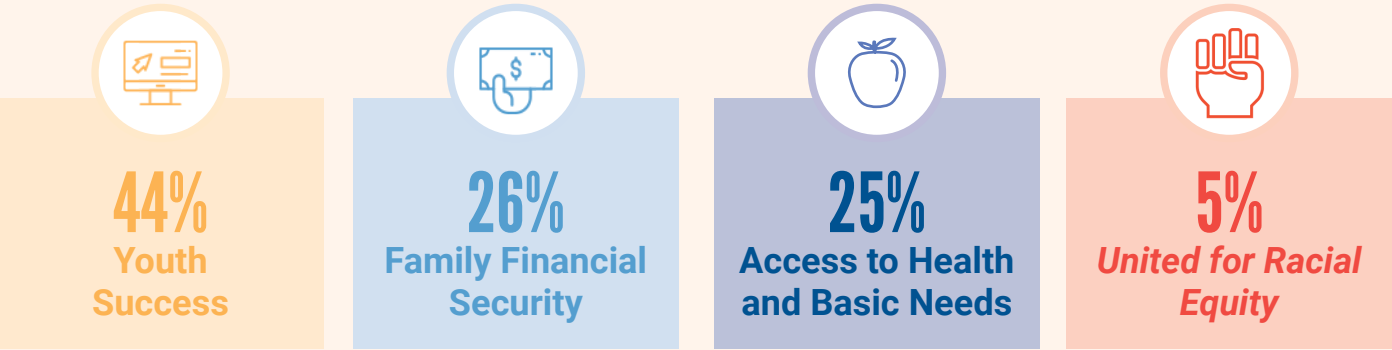
