As members of our Tocqueville and Constitution Societies, your generous contributions to the 2022 United Way Community Campaign helped us build equitable outcomes for children and families in our community. During the 2022 United Way Campaign, **more than 400 Tocqueville Society and Constitution Society members donated \$1,000 or more directly to United Way.**

Your philanthropic leadership investment, combined with other gifts, helped raise nearly \$8 million and made a measurable difference for children and families. Here's how:

- 91 percent of students improved literacy skills through participation in weekly one-on-one reading sessions with a United Way volunteer.
- 88 percent of children ages birth to five met age-appropriate developmental milestones, entering school ready to learn.
- 8,853 people found safety and protective services from sexual assault or domestic violence.
- 13,500 people filed their 2022 tax returns at no cost through Volunteer Income Tax Assistance sites and MyFreeTaxes.com returning **\$20M** in federal refunds and credits to our community.
